Henry County Community Development Block Grant (CDBG) Program announces the release of the draft federal fiscal year 2020 Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER provides the U.S. Department of Housing and Urban Development (HUD) and the residents of Henry County an opportunity to evaluate the overall progress of the CDBG Program in carrying out priorities and specific objectives identified in the FY 2020-2024 Consolidated and Annual Action Plans. It also describes actions, changes, and accomplishments during the 2020 Program Year resulting from the Community Development Block Grant (CDBG) Program funded through HUD.

Henry County proposes that the federal fiscal year 2020 CAPER be approved, in accordance with its Citizen Participation Plan and the regulations of HUD that govern the CDBG Program. The County encourages all residents and other interested parties to review the draft FY 2020 CAPER and submit their written comments during the public comment period which shall be in effect from Saturday, September 4th, 2021 thru Monday, September 20th, 2021. A receipt of all comments received will be submitted to HUD as part of the CAPER.
